Exhibitor Wristband, Good for All Four Days of the Fair - \$16.00: For parents and family members of Jr. livestock/small animal exhibitors, FFA Instructors, 4-H Leaders and Senior Livestock Exhibitors. Wristbands will be available for purchase at the ENTRY OFFICE (caboose) from Tuesday, June 23rd from 10:00 a.m. to 8:00 p.m. and on Wednesday, June 24th from 9:00 a.m. to 8:00 p.m.

Judging: Judging will not be held in any class for late exhibitors.

Still Exhibit Release: Exhibits may be claimed on Monday, June 29th from 3:00 p.m. to 6:30 p.m. Entries and exhibits not claimed by 4:30 p.m. on Friday, July 31st will be disposed of at the Fair's discretion.
